- The merit and the sporting results of the candidate in terms of his participation in the CLIO CUP SERIES, and his previous achievements in any other international/national motorsport championship.
- Compliance with payment deadlines for all invoices issued by ALPINE RACING, or any championship partner up to now. Any driver or any team whose manager or owner is or has been a manager or owner of another team with debts to the Alpine Racing Spare Parts Department or to an official supplier of the CLIO CUP SERIES, including debts from a previous year, shall be refused its participation in the 2023 CLIO CUP SERIES.
- Compliance with payment for official financial penalties during a previous season
- The acceptance of sporting and technical decisions in any international/national motorsport championships;
- The words, actions or writings, would have caused moral or material prejudice to RENAULT SAS, its subsidiaries or ALPINE RACING, its employees or its managers, including in previous sports seasons,

The CLIO CUP SERIES Organizing Committee reserves the right to take into account any other criteria that it may consider relevant, in relation to the sporting and economic requirements the CLIO CUP SERIES must meet.

## V. PERSONAL DATA

Alpine Racing may process the Driver and Team's personal data. The Driver and Team's personal data are processed by Alpine Racing for the conclusion and performance of the Selection process and for the smooth running of the championship (including in relation to the promotion of the Championship).

The personal data collected are kept for the duration of the Championship and then archived for a period of 2 (two) years from the end of the Championship.

The Team has the right to obtain communication of its personal data, and if necessary, to request the rectification, the limitation, the deletion of its personal data and/or may object to the processing of its personal data, for legitimate reasons, by contacting Alpine Racing at the following address: privacy@fr.alpineracing.com.

Alpine Racing and the Applicant shall, at all times, comply with their obligations under the applicable data protections laws, in particular Law No. 78-17 of 6 January 1978 in its latest version, Law No. 2018-493 of 20 June 2018 on the protection of personal data and the General Data Protection Regulation (EU) 2016/679 (the "Regulation").

#### VI. ADDITIONAL INFORMATION

I undersigned, the competitor, and the driver, we state on our

honour that information above are truth.

We hereby certify that our licence is not suspended, and that we would render null and void any previous entry made for any competition if our licence is suspended. We engage ourselves to inform the Organising Committee within the 24 hours following any suspension or at the latest before the end of the administrative checks of the 1st event following the suspension of our licence.

We engage ourselves to provide, at least 7 days before the 1st event, to the Organising Committee with the preliminary authorisation from our ASN to participate in the 2023 CLIO CUP SERIES events as required in Article 3.9.4 of the International Sporting Code and to inform in the case of any suspension of it afterwards.

We undertake to take out any mandatory insurance required by the laws and regulations in place in relation to the practice of motorsports.

We undertake to abide by the Sporting and Technical Regulations (as supplemented or amended) governing the 2023 CLIO CUP SERIES, by the International Sporting Code, by the specific regulations of each event, by the prescriptions given at the event briefings by the Race Director, and by the instructions, requirements, decisions and/or sanctions taken by the Organizers' staff, the organizing committee, or the Officials at each event and test.

We are informed and acknowledge that participation in the Events and Tests is dangerous and could involve the risk of serious injury to our person and/or death and/or damage to our property, notably but not exclusively in the event of collision or some other accident. In particular, we acknowledge that we will be involved in driving high performance vehicles around the circuits. We also expressly acknowledge and accept that any injuries received by us may be compounded, worsened or increased by any emergency rescue operations which are necessary or carried out in the event of an accident or emergency on the day.

We declare that we are physically and mentally fit to take part in the event(s) and we are competent to do so.

We acknowledge having the necessary skills to compete in an event of the type to which this entry relates and that the vehicle entered is suitable and roadworthy for the event having regard to the track and the speeds which will be reached.

We agree to indemnify and hold harmless Alpine Racing for any loss or damage, liability or costs (including but not limited to expenses, legal fees and charges) suffered or incurred by Alpine Racing, which would be the direct or indirect consequence of any damage caused to a circuit or track infrastructure by the Team, any of its Cars, personnel, contractors and/or driver(s).

We undertake to abide by the rules forbidding the use of drugs, alcohol and prohibited substances described by the Sporting International Code – Appendix A; we agree to potential testing by the official medical doctors.

The signatures of the Competitor/Driver grant permission for Alpine Racing, series sponsors and event promoters free of any charges, duties or fees, to use, reproduce, have reproduced, show, have shown, without limitation in space or time, all soundtracks, films/video pictures concerning the Competitor, the Driver, team members or cars involved in the Events on any medium whatsoever for any documents, reports, coverage, broadcast, program, publication, software, etc. whether past, present or future. The organizer may freely assign its rights to a third party.

The installation of recording, broadcasting or transmitting devices on any car taking part in the Events is subject to a previous authorization from ALPINE RACING.

We shall strictly comply with Appendix S to the International Sporting Code, (COVID-19 Code of Conduct) issued by the FIA (the "Protocol") at all times when attending each Event and Test. We shall also strictly comply with any and all national, regional and/or local laws and regulations (the "Applicable Laws"), recommendations, sanitary protocol and any other information or instruction communicated by ALPINE RACING, the ASN, the FIA, the promoter of the Event or Test and/or the circuits themselves (collectively the "Applicable Rules").

We assume the risk of our personnel suffering an illness or fatality related to COVID-19 as a result of our participation in the Events or Tests, and agrees (on behalf of our personnel, and on behalf of our estate, heirs, successors and assigns) that ALPINE RACING shall bear no liability in respect of any such illness or fatality unless it is proven that the illness or fatality was suffered as a result of one of the ALPINE RACING's wilful misconduct or gross negligence.
